Taxation in Germany is in many respects different, comparing to other countries. The most important tax in Germany is the income tax, i.e. the tax on the wages. The amount of income tax employees are paying depends on income itself as well on the tax brackets. Submission of the tax return to the tax office is voluntary, but in some cases might be compulsory. These taxation basics will be highlighted during the event and are especially worth to know for international professionals and newcomers.

Furthermore, income taxation is one of the most crucial aspects of employment or posting of expats. Income tax underlies various legal regulations and agreements in frames of global mobility assignments and cross border secondments. HR-managers in companies and expats need to be familiar with the main German and international legal income tax specifics to arrange an expat assignment in Germany smoothly.

Expats from all over the world are living and working in Germany. Some of them are local employees, some are commuters, other are on a short- or long-term assignment and come from European or non-European countries. Which impact has the income tax in Germany in different expat-situations? Which factors may influence the income-tax? In which cases implies limited or unlimited income tax liability? And how the international Double Taxation Agreements function? These and other questions on income tax for international employees / expats will be answered at the event, following by the networking and professional exchange.

Our two speakers from the field of tax consulting will present the topic of taxation in possibly simple, comprehensible way, and will try to make this quite complex, but very important topic coherent for HR-specialists as well as for expat-newcomers.

Ms. Alexandra Serlinger is a tax lawyer, specialized in wage taxes for international employees, employees on assignment / expats and further cross border income taxes. Ms. Serlinger studied International Law in



France, Paris and in Germany, worked for 12 years in several leading law firms including KPMG which is one of the Big-4 consulting companies worldwide. Since 2021 she has been working as self-employed tax lawyer and provides tax-consulting services for companies and their employees, especially expats. In her presentation during the event, Ms. Serlinger will highlight general aspects of taxation in Germany, tax declaration as well as issues of cross boarder income taxation in Europe.

Ms. Saeko Kawazoe is a German attorney at law and tax adviser, specialized in international taxes, tax consulting for medium-sized

companies, international enterprises and their employees. Ms. Kawazoe studied Law in Germany, Düsseldorf and has been working for more than 10 years as a tax adviser. Today she is a Head of Japanese Desk and tax advisor at the consulting company Dr. Ganteführer, Marquardt & Partner. She speaks German, English and Japanese, and provides regularly consulting services on wage tax for Japanese companies and expats. In her presentation Ms. Kawazoe will talk about tax liability in case of posting of international employees from non-European countries to Germany, the world income principle and Double Taxation Agreements.
